

# Paracanoe Senior & Paralympic Team Selection Policy 2024

## SECTION A: PURPOSE AND PRINCIPLES

### 1. Purpose

The purpose of the Paracanoe selection policy is to clearly outline the processes which will lead to the selection of the GBR Paracanoe Teams for all 2024 international events named within this policy. It also aims to support the longer-term goals of the Paracanoe Programme to LA 2028 and beyond.

### 2. Principles

- 2.1 The primary focus of the 2024 Paracanoe Selection Policy is to maximise medal winning opportunities at the 2024 Paris Paralympic Games, with a secondary focus on providing racing opportunities for athlete development across sport classes and classification categories.
- 2.2 The Selection Policy seeks to select the best athletes in a transparent way that prioritises optimal preparation time for achievement of successful performance at 2024 international competitions.
- 2.3 Selection/nomination will be based on results in selection races and subject to achievement of a performance standard.
- 2.4 The selection policy is designed to enable athletes to develop individualised training programmes to best suit their competition goals.

## SECTION B. ELIGIBILITY AND PERFORMANCE STANDARDS

### 3. General Eligibility

- 3.1. To be eligible to be selected to any 2024 GBR Team, athletes must meet the following conditions (full detail can be found in British Canoeing's [Eligibility Policy](#)):
  - 3.1.1. Be a full member of British Canoeing or Home Nation Association that enables participation in competition.
  - 3.1.2. Meet age, classification, nationality and all relevant eligibility criteria for international competitions in accordance with competition rules laid down by the [International Canoe Federation](#) (ICF) and the [European Canoe Association](#) (ECA). In addition, selection for the Paralympic Games will be subject to [British Paralympic Association](#) (BPA) and [International Paralympic Committee](#)(IPC) eligibility criteria. The first year a junior can compete at World and European Senior Championships and Paralympics is the year of their 15<sup>th</sup> birthday.
  - 3.1.3. Athletes on a funded programme need to have signed their Programme Athlete Agreement. Athletes outside Programme funding will also be expected to sign up to the British Canoeing Great Britain Team participation agreement on accepting selection at least two weeks before travelling to the first competition.
- 3.2. Where athletes compete in more than one eligible selection event, the policy will be applied in isolation for each specific event.
- 3.3. All eligible athletes will be considered equally for selection against the stated selection criteria regardless of club, training location, age, Home Nation and programme status.
- 3.4. British Canoeing reserves the right to deselect an athlete who has been found guilty of a disciplinary offence under British Canoeing/ICF rules. This includes doping offences.

### 4. Paracanoe Regatta Eligibility

- 4.1. **Regatta qualification 2024** - Subject to receiving Special Dispensation (see Section 4.2.2) to compete at National Regattas including Paracanoe Selection Regattas athletes must:
  - 4.1.1. hold a National Classification (to book a classification slot, athletes should contact [macauley.allen@britishcanoeing.org.uk](mailto:macauley.allen@britishcanoeing.org.uk)) in the sport class they wish to be selected for or be no more than 2 points over the defined cluster score for one test (leg, trunk or on-water) and also be within the correct cluster scores for the other tests for the sport class they wish to compete in (see classification overview ([here](#)) for details of scores, clusters and sport classes).

- 4.1.2. have achieved the 2024 Paracanoe Regatta Qualification Time (Appendix1) in a [Paracanoe specification boat](#) at any of the below:
- 4.1.2.1. A UK National or International Regatta (World Championship, European Championship or World Cup) in the 18 months prior to the relevant 2024 selection regattas, April **13<sup>th</sup>/14<sup>th</sup>** (15<sup>th</sup>) and June **7<sup>th</sup>/8<sup>th</sup>** (9<sup>th</sup>).
- 4.1.2.2. Paracanoe assessment events: For details, contact [attila.herbert@britishcanoeing.org.uk](mailto:attila.herbert@britishcanoeing.org.uk)  
**OR**
- 4.1.2.3. Be a Paracanoe Talent Academy Athlete with evidenced 200m training data in the 18 months prior to the relevant 2024 selection regattas, April **13<sup>th</sup>/14<sup>th</sup>** (15<sup>th</sup>) & June **7<sup>th</sup>/8<sup>th</sup>** (9<sup>th</sup>).
- 4.2. **Assessment Events & Special Dispensation to compete at National Regattas**
- 4.2.1. Athletes who have not achieved the Paracanoe Regatta Qualification Time in the 18 months prior to an official competition should attend a Paracanoe assessment event by contacting ([attila.herbert@britishcanoeing.org.uk](mailto:attila.herbert@britishcanoeing.org.uk)). If an athlete achieves a 2024 Paracanoe Regatta Qualification Time at an eligible assessment event they will be eligible to enter the Paracanoe selection regattas, April **13<sup>th</sup>/14<sup>th</sup>** (15<sup>th</sup>) and June **7<sup>th</sup>/8<sup>th</sup>** (9<sup>th</sup>).
- 4.2.2. Athletes who have achieved an A Final at World Championships, European Championships, or World Cup in 2022, 2023 or 2024 who have achieved the Regatta Qualification Time for their event outside of 2023/2024 Official Regattas may be entered into selection competitions by receiving Special Dispensation by the Paracanoe IP. Athletes wishing to apply for Special Dispensation to enter selection events must do so, in writing, at least 3 weeks prior to the regatta by notifying the Paracanoe Lead (or their designee) stating the grounds for the application and providing supporting evidence. The Paracanoe Lead (or their designee) will then submit an application to the Paracanoe IP who will consider along with evidence of performance based on the criteria in Table 3 on Appendix 1.
- 4.3. A list of athletes who have achieved the regatta qualification time and performance standards will be published on the BC website at least 1 month before the selection event (by 13th March 2024).
5. **Performance Standards**
- 5.1. All Selections and Nominations made under this policy will be subject to the athlete achieving the relevant performance standard for each event as laid out within **Appendix 1** at the selection race or a UK National or International Regatta (World Championship, European Championship or World Cup) in the 18 months prior to the relevant 2024 selection regatta (April **13<sup>th</sup>/14<sup>th</sup>** (15<sup>th</sup>) and/or June **7<sup>th</sup>/8<sup>th</sup>** (9<sup>th</sup>)).
- 5.2. Where a place(s) remain unfilled following selection in any one of the ICF sport classes (Table 1), the IP may at its sole discretion consider selecting/nominating an athlete based on classification, development needs and athlete trajectory, irrespective of achievement of the performance standard at 5.1.

## SECTION C: GREAT BRITAIN PARACANOE TEAM SELECTION 2024

Selection to represent Great Britain at International Paracanoe competitions will be based on the ICF sport classes listed in Table 1.

There are up to two selection points in 2024. The selection points differ for events in which GBR Paracanoe have achieved NPC Quota Slots in 2023 and events in which GBR Paracanoe are looking to achieve the NPC Quota Slot at the 2024 World Championship/2<sup>nd</sup> round qualification (Table 1).

6. **Paracanoe Team Selection Overview (Process for events where Quota slots were achieved in 2023)**
- 6.1. Selection for the World Championships and European Championships will take place at the April regatta on April **13<sup>th</sup>/14<sup>th</sup>** (15<sup>th</sup>).
- 6.2. Selection for the Paralympic Games will take place at the Regatta on June **7<sup>th</sup>/8<sup>th</sup>** (9<sup>th</sup>).
- 6.3. The stand-alone selection point June **7<sup>th</sup>/8<sup>th</sup>** (9<sup>th</sup>) for the Paralympic Games allows athletes the option to prepare for this without the constraints of a multi-point selection.
7. **Paracanoe Team Selection Overview (Process for events where Quota slots were not achieved in 2023)**
- 7.1. Athletes must compete in the April regatta, April **13<sup>th</sup>/14<sup>th</sup>** (15<sup>th</sup>) for a place at the World Championships/2<sup>nd</sup> round qualification and European Championships.
- 7.2. Athletes obtaining the NPC quota slot at the World Championship/2<sup>nd</sup> round qualification will be nominated for Paralympic Games selection. Nominations will be forwarded to the BPA for final approval following the June regatta, June **7<sup>th</sup>/8<sup>th</sup>** (9<sup>th</sup>)

## 9. World Championships /2<sup>nd</sup> round qualification – Szeged (HUN)

- 9.1. **World Championships/2<sup>nd</sup> round qualification – Szeged (HUN)** is designated as a **Senior Team** event.
- 9.2. In line with the stated principles of the policy, the IP reserves the right to select an athlete(s) in specific event(s) to the World Championships team who finishes outside of the top 2 positions in order that they can achieve the eligibility criteria to compete at the Paralympic Games. In making this decision the IP will consider.
  - 9.2.1. The result and their percentage away from the winning boat (this percentage can be different for each classification based on assessment of the world field)
  - 9.2.2. The previous performance or progression rate of the athlete and their likelihood of achieving Paralympic Games selection.
  - 9.2.3. Maximising reserve options for the Paralympic Games.
  - 9.2.4. Which of the top two athletes should be replaced.
- 9.3. Selection is determined by the ranking system as described in section 12 and subject to attainment of the performance standard at 5.1.
- 9.4. Up to two athletes per sport class will be selected where the selection criteria within this policy is met.

## 10. European Championships – Szeged (HUN)

- 10.1. The European Championships is designated as a mixed **Senior** and **Development Team** event. Athletes who have previously competed internationally (**Senior Team**) will be required to meet the relevant Senior Team Performance standard and athletes without previous international start line experience or with classification needs (**Development Team**) will be required to meet the relevant Development Team Performance Standard.
- 10.2. All eligible athletes racing at the April **13<sup>th</sup>/14<sup>th</sup>** (15<sup>th</sup>) selection event will be selected to the European Championship pool and a ranking order established in accordance with section 12. Athletes will be required to accept the selection for European Championships pool by Friday 21<sup>st</sup> April.
- 10.3. Following the Paralympic selection event, June **7<sup>th</sup>/8<sup>th</sup>** (9<sup>th</sup>) athletes nominated for Paralympic Games will be removed from the European Championships pool and up to two boats per sport class from the remaining athletes from the April regatta ranking will be named as the European Championship team.

## 11. Nominations - Paralympic Games – Paris (FRA)

- 11.1. Paralympic Games – Paris (FRA) is designated as a **Senior Team** event for the purposes of Appendix 1.
- 11.2. One athlete per sport class will be nominated either based on the ranking system described at Section 12 at the relevant event on June 7th/8th (9th) **or** following qualification of a quota place at the World Championships (as set out in section 6 and 7)
- 11.3. Where an athlete has met the nomination criteria and is able to double up in K1 and Va'a, the IP will nominate the athlete for a primary event in line with the primary focus of the selection policy (2.1).
- 11.4. Nominations for double up events are subject to achievement of all other eligibility and performance standards in that event.
- 11.5. All Paralympic nominations will be forwarded to the BPA and for ratification and final approval following the June regatta, June 7<sup>th</sup>/8<sup>th</sup> (9<sup>th</sup>). All nominations remain confidential until the BPA and Performance Director grant permission for them to be released.

## 12. Calculation of ranking at Paracanoe selection regattas

- 12.1. Ranking is based on the best single position achieved by an athlete from two races.
- 12.2. Where two athletes have an equal ranking for a position after two races, a race-off will take place to determine final placing.
- 12.3. Should the race-off result in a tie, the fastest time recorded in the first two races will decide the ranking.
- 12.4. The winner of the race-off will be awarded the highest placing.
- 12.5. To be eligible to race off for a position, an athlete must have finished in that position or higher in the first two races.
- 12.6. At the April regatta, April 13<sup>th</sup>/14<sup>th</sup> (15<sup>th</sup>) all athletes that have achieved their relevant performance standard (for **Senior or Development team**) will be given a ranking.
- 12.7. At the June regatta, June 7<sup>th</sup>/8<sup>th</sup> (9<sup>th</sup>) every athlete that has achieved the **Senior Team** performance standard will be given a ranking.

## 13. General Provisions

- 13.1. The IP reserves the right not to nominate, or to de-select for any of the 2024 international events covered to in this selection policy, any athlete or reserve on the following grounds:
  - 13.1.1. Medical grounds – i.e., when an injury/illness may, in the reasonable opinion of the IP, inhibit the achievement of appropriate performance.
  - 13.1.2. Suitability as a team member, where for example (but not limited to) an athlete's behaviour or attitude leads the IP to determine in its opinion that the selection of such athlete would be inappropriate; or
  - 13.1.3. Poor form – i.e., when an athlete's form in events and/or training has decreased to a level which, in the opinion of the IP, would inhibit the achievement of appropriate performance.
- 13.2. Such decisions will only be taken following consultation with the athlete, appropriate BC coaches and/or medical reports. For the Paralympic Games, Paralympics GB will also be included in the consultation.
- 13.3. A non-travelling reserve may be named in each individual event based solely on ranking in the identified selection race where performance standards have been achieved. In order of selection, named reserves will only travel in the event of injury or illness to a selected athlete or where a place(s) is declined. Reserves will be considered up until the final entry and registration deadlines published by the ICF and IPC (05/08/2024)

## SECTION D: CONTINGENCY AND EXCEPTIONAL CIRCUMSTANCES

### 14. Contingency - The IP retains the right to implement contingency measures where circumstances arise that prevent full, fair and competitive racing and adapt racing to ensure as fair a selection process as possible. This may include circumstances such as weather conditions and Covid-19 implications.

- 14.1. The IP will monitor weather conditions in advance of, and during a selection race, and has a process for communication of real-time information in this regard.
- 14.2. If weather conditions or other significant issues arise rendering it inappropriate or impossible to conduct a selection race during or, in advance of competition, the IP may declare that a race(s) will not be used for selection and invoke one or more of the following non-exclusive alternatives.
  - 14.2.1. Rescheduling of any affected selection race(s) to early morning/ evening racing within the same regatta (if scheduling and weather conditions permit)
  - 14.2.2. Rescheduling of any affected selection races to an alternative competition (if appropriate)
  - 14.2.3. Rescheduling to a reserve date if available and appropriate. Amending lane draw for direct comparability of performances

- 14.3. Any decision made under these provisions of the policy will be made by a minimum of two IP Members and where possible, in consultation with the chief official.
- 14.4. All IP announcements relevant to contingencies will be posted on [www.britishcanoeing.org.uk](http://www.britishcanoeing.org.uk). During competitions, important information will be posted at race control on the live results messaging, on the British Canoeing social media or messaging App.
- 15. Exceptional circumstances** - Should an athlete miss a Selection event due to illness or injury during, or prior to, elements of the 2024 selection process; or have any other exceptional circumstances, the IP reserves the right to provide an opportunity for such a boat to be eligible for selection. For the purposes of this clause, exceptional circumstances are unplanned, unexpected, unavoidable and unforeseen.
- 15.1. Where an athlete wishes to invoke this clause, exceptional circumstances requests should be directed to the IP prior to the commencement of the selection competition via email at [enquiries.internationalpanel@britishcanoeing.org.uk](mailto:enquiries.internationalpanel@britishcanoeing.org.uk) and should provide:
- 15.1.1. Certificated evidence of illness or injury, or other significant exceptional circumstance.
- 15.1.2. Any evidence the athlete wishes the IP to consider which demonstrates in both training and racing, a superior performance level than other selected athletes.
- 15.2. To be considered for an exceptional circumstances, an athlete must be able to demonstrate the following performance level:
- 15.2.1. Achieved the A final or placed in the top 3 in the B final in a Paralympic Event at a World Championships in the 24 months prior to the selection event.
- 15.3. When considering whether an athlete meets the criteria outlined above, the IP will consider the athlete's training and racing profile (from GBR performance analysis data)
- 15.4. Where the IP accepts an exceptional circumstance request following the process detailed above, the IP reserves the right to:
- 15.4.1. Identify a single race opportunity whereby the lowest ranked boat that has been selected and the identified athlete(s) would compete for a GBR Team place. If this situation arises more detail would be provided following the IP meeting immediately after the appropriate Selection race series. Where no athlete has been selected for the relevant event under this policy, accept the exceptional circumstances and select the athlete;
- 15.4.2. Substitute the selection of the athlete under this policy with the selection of the athlete making the exceptional circumstances request.
- 15.5. All decisions under this Clause that relate to injury, illness (including Covid-19) or medical conditions will be determined by the IP members. When assessing if an athlete is fit to race, the decision of the IP is final.
- 15.6. **The IP has the sole discretion to invoke the provisions in this clause and any decision is final and not subject to appeal.**

## SECTION E: GENERAL INFORMATION

### 16. Responsibility

The Canoe Sprint & Paracanoe IP (IP), which is appointed by and reports to the Board of British Canoeing, is responsible for all aspects of developing, approving and managing the implementation of the Canoe Sprint & Paracanoe selection policies. The Terms of Reference can be found [here](#).

### 17. Conflicts of Interest

Any member of the IP shall declare any conflicts or potential conflicts of interest and shall refrain from participation in the discussion of and any vote in respect of any selection matter in which they have a material conflict of interest. If a person has any queries in this area, they should consult the British Canoeing Director of Governance.

### 18. Policy Changes

- 18.1. The selection policy may be amended at any time by British Canoeing for one or more of the following circumstances:
- 18.1.1. Any changes in rules governing a particular event;
- 18.1.2. Any change in ICF eligibility, rules or programme of events;
- 18.1.3. To give effect to the selection process in case of a drafting error or oversight
- 18.1.4. To clarify any ambiguity to the intended meaning of the selection policy
- 18.1.5. Any other reason determined by British Canoeing at its total discretion that is in the best interest of British Canoeing and in line with the principles outlined for selection
- 18.1.6. Circumstances arising from Covid-19 restrictions
- 18.2. Any changes will be communicated on [www.britishcanoeing.org.uk](http://www.britishcanoeing.org.uk)

## 19. Appeals Procedure

- 19.1. The British Canoeing Appeals process applies to all decisions made under this policy and can be found [here](#).
- 19.2. UK Sport funded World Class Programme athletes who require support and advice can contact the BEAA at [support@britishathletes.org](mailto:support@britishathletes.org). Any athletes who have questions regarding the selection decision may contact the International Panel [enquiries.internationalpanel@britishcanoeing.org.uk](mailto:enquiries.internationalpanel@britishcanoeing.org.uk). Any athletes who have questions regarding the appeals process may contact [appeals@britishcanoeing.org.uk](mailto:appeals@britishcanoeing.org.uk)

## 20. Data Protection

- 20.1. British Canoeing is a privacy conscious organisation and is strongly committed to an individual's right to privacy. All data gathered during the selection process will only be utilised for the purposes of an athlete's participation in a GBR Paracanoe Team. This may include administering their event/race entry and certain information may be published as part of the results and rankings of the event/race.
- 20.2. Any personal data will be processed and stored in compliance with the British Canoeing Data Protection Policy and in accordance with all applicable Data Protection laws in effect at the time of publication of this Selection Policy, including but not limited to, the Data Protection Act 2018 and UK GDPR.
- 20.3. Further information on British Canoeing's approach to privacy and data protection, including British Canoeing's privacy notices, policies and contact details, can be located in their Privacy Centre (<https://www.britishcanoeing.org.uk/about/privacy-centre>). Should an athlete wish any data British Canoeing hold relating to them to be deleted at any point; they should contact British Canoeing at [GDPR@britishcanoeing.org.uk](mailto:GDPR@britishcanoeing.org.uk).

## 21. Policies

This Selection Policy operates in conjunction with all relevant British Canoeing policies including but not limited to, Equality, Anti-Doping Policy, Pregnancy, Safeguarding, Anti-Bullying Policy and Anti-Bribery Policy.

## 22. Communications

British Canoeing is committed to providing open and informative communication in relation to selection. All athletes will receive formal confirmation of the selection and for those athletes who wish to discuss the outcome of decision made by the IP, the Chair of the IP will be available to speak informally to athletes and in the case of minors, parents.

## 23. Force Majeure

"Force Majeure" means any act, event, omission, cause or circumstance not within the reasonable control of British Canoeing or the race organisers, including but not limited to any strike, lockout or other industrial action, any civil commotion or disorder, riot, invasion, war or terrorist activity or threat of war or terrorist activity, any action taken by a governmental or public authority of any kind (including, without limitation, not granting a consent, exemption, approval or clearance), any fire, explosion, storm, flood, earthquake, subsidence, epidemic or other natural physical disaster. In the event of such Force Majeure affecting the application of the policy, the IP shall have the sole discretion, in consultation with the British Canoeing Head of Governance, to make a decision in line with the principles, strategy and mission of this selection policy.
