# Introduction

British Canoeing, the Canoe Association of Northern Ireland, the Scottish Canoe Association and Canoe Wales committed to promoting and supporting clean sport within the UK. The sport recognises the contribution that sport can make to health, national pride and social development when supported by a strong ethical and moral environment in which to develop.

Integrity, fairness, equity and respect as values are core to success in canoeing and the National Associations are committed to playing their part in ensuring that the paddling community provides an environment that supports fair play and clean sport, which can be nourished by a clear and comprehensive education and information strategy.

The National Associations are working in accordance with the National Anti-Doping Policy (NADP) rules which are the UKs interpretation and application of the WADA code. The basic principle of which is to preserve the spirit of sport and protect the right of all paddlers to compete in doping-free sport.

As part of the code, the National Associations are committed to supporting and providing antidoping education to paddlers and support personnel, at a variety of levels to ensure all paddlers remain current with anti-doping information and can make informed choices.

To ensure the National Associations support the philosophy of clean sport an Anti-Doping education strategy, "Paddle Clean", has been developed in conjunction with UKAD, which is based on a long-term and systematic approach to anti-doping education to prevent doping and firmly integrate this into a paddler's development.

# **Adoption**

British Canoeing's Anti-Doping policy is adopted by the National Associations under a single agreement and this Paddle Clean Strategy is adopted and supported by:









Sitting alongside this collective Education Strategy are individual National Association implementation plans.

# **Collaboration & Driving Change**

The National Associations recognise the need to embed anti-doping across its working areas, with every aspect of business adopting strong anti-doping principles and taking responsibility for the delivery of our Paddle Clean Education Strategy and annual implementation plans. The 'Anti-Doping Working Group' will bring together representatives with expertise from across the National Associations to drive progress in delivery and provide a forum where ideas can be generated and discussed, problems be identified and resolved. This group will meet a minimum once a year and shall consist of:

# **Strategic Objectives**

# **ENGAGE - INFORM - EMPOWER**

- 1. Raise awareness of clean sport and doping free behaviour to the competition paddling community.
- 2. Engage paddlers and support personnel across the competition pathway providing appropriate level information and understanding in order to create a culture of clean sport and avoid inadvertent doping.
- 3. Provide a range of targeted educational programmes to talent/development programme, national team and world class programme athletes and support personnel to provide them with the information, tools and understanding in order to compete clean.
- 4. Raise awareness of the British Canoeing's Paddle Clean education programme and effectively deliver key messages through a range of communication channels.

# **Risk Analysis**

### Strengths

- Consistent sport wide approach across the UK, with clarity of roles and responsibilities across the pathway.
- Strong culture of clean sport in the sport in the UK.
- Existing education programme and history of education of athletes and support personnel.
- Positive messaging from a cohort of athletes within education settings.

### Weaknesses

- Resource, financial and personnel, to deliver the strategy.
- Breadth of entry points into the sport e.g. schools, universities, clubs, independent paddling, direct into national team.
- Breadth of the sport with multi disciplines to support and resource each with their different structures.
- Cross over between recreational and competitive paddlers.

# **Opportunities**

- Collaboration and sharing of resources between National Associations.
- Collaboration using online delivery for cross nation workshops.
- Use the digital landscape to raise the profile of clean sport through the pathway.
- Use our athletes as ambassadors to promote clean sport.

### **Threats**

- Complacency of athletes and support personnel who have been in the system for a prolonged period.
- Lack of workforce to deliver required education programmes.
- Availability of supplements not on informed sport.
- Unregulated industry with false promotions and increased media around body image and generic gym supplement use.
- The funding system around Olympic and Paralympic sport potentially adding pressure for performance on individuals.
- Known doping in Sprint Canoeing in other nations. Coaches or support personnel coming into the UK system from a different anti-doping culture.

# **Sport Systems & Significant Partners**

### **Governance Structure**

British Canoeing is the National Governing Body (NGB) for paddling in England and has a number of UK wide directives. The Canoe Association of Northern Ireland (CANI), the Scottish Canoe Association (SCA) and Canoe Wales (CW) are the respective member bodies for paddling in Northern Ireland, Scotland and Wales.

British Canoeing is the member body of the International Canoe Federation, European Canoe Association and International Rafting Federation. At a UK level British Canoeing has responsibility for setting strategy and framework for international teams, anti-doping, coaching and competition.

British Canoeing adopts the UKAD Rules with a small number of amendments and supplemental provisions as detailed in the British Canoeing Anti-Doping Rules. CANI, the SCA and CW operate under the British Canoeing Anti-Doping Rules.

The Paddle Clean education strategy supports the following core disciplines which are recognised by the International Canoe Federation (ICF) and European Canoe Association (ECA).

- Canoe Freestyle
- Canoe Marathon
- Ocean Racing
- Paracanoe
- Canoe Polo
- Canoe Slalom
- Canoe Sprint
- Wildwater Racing
- Stand Up Paddling


Whilst Canoe Sailing is a recognised discipline by the ICF and the National Associations, the National Associations have limited engagement with the sport administrators and participants. As such participants can engage through central digital resources but proactive education will not be undertaken, unless specifically requested.

British Canoeing is the NGB for the sport of rafting in the UK under the auspices of International Rafting Federation (IRF). As such this Paddle Clean education strategy will fully integrate rafters in the UK within it.

British Canoeing is also the member body of the World Surf Kayak Association for Surf Kayak in England, with CANI, the SCA and CW the respective member bodies for Northern Ireland, Scotland and Wales.


### **Participation Structure**

Paddlesport encompasses a broad range of paddlers from recreational paddlers enjoying the sport for exercise and mental health benefits and being in the natural environment through to competition paddlers competing at the elite end of the sport.




### **Sport Systems**

The below identities the sporting landscape within which canoeing athletes and the National Associations operate. Through engagement with key influencers and partners, the culture of clean sport can be strengthened. This strategy principally focuses on the pathway from talent and national level athletes through to National Teams and Olympic/Paralympic programme athletes and support personnel.



# **Target Groups**

Paddling has its own unique pathway with a differentiation between competition and recreational paddlers. Education will be delivered to all athletes, coaches and ASP on the competition pathway.



Targeted education will be delivered to athletes, coaches and ASP in the top two tiers of the pathway - World Class Programme, Discipline Committee National Team and Talent/Development programmes. Parents of paddlers on the Talent/Development programmes will also have the opportunity to access education.

Athletes selected for ICF and/or UKAD testing pools will receive bespoke training on the requirements and ADAMS system.

Athletes and ASP selected on the Olympic and Paralympic Games long list will be required to complete Clean Games education.

Education (delivered by British Canoeing) will be mandatory for athletes returning from a sanction, regardless of the level within which they compete.

Competition paddlers and national level athletes will be able to access open education and outreach sessions, in addition to clean sport messaging provided through media/communications channels.

Recreational paddlers are deemed to engage in the sport for reasons not associated with competition and as such will not receive clean sport education. Anyone following the National


Association social media channels will be able to engage through this route, and likewise through the NGB websites.

National Associations have minimal delivery and engagement with school activities. Any enquiries will be signposted and the Get Set Network resources promoted.

- Values-Based Education: Delivering activities that emphasise the development of an individual's personal values and principles. It builds the learner's capacity to make decisions to behave ethically
- Awareness Raising: Highlighting topics and issues related to clean sport
- Information Provision: Making available accurate, up-to-date content related to clean sport
- Anti-Doping Education: Delivering training on anti-doping topics to build competencies in clean sport behaviours and make informed decisions

# **Ambassadors**

British Canoeing will appoint three Paddle Clean Ambassadors to help increase awareness, engage with athletes and support personnel, and provide input into the Paddle Clean Strategy through an Athlete Representative on the British Canoeing Anti-Doping Working Group. Appointments are made on a four year basis (submit to bi-annual review) by the Anti-Doping Working Group.

# **Resources – Workforce & Financial**

## **Clean Sport Workforce**

Each National Association will appoint a Board Member and Anti-Doping Lead Officer to oversee the organisation's anti-doping responsibilities.

The Anti-Doping Lead Officer will oversee the development and delivery of its respective implementation plan and management of its workforce.

Educators will be paid expenses for delivery of clean sport education. Discussions will be held as to whether Educators, who are not staff or board members, should be paid a fee for delivery. All Educators will be encouraged to engage with the UKAD knowledge development sessions. Feedback forms will be monitored by the Anti-Doping Lead Officer and CPD arranged as required to develop specific areas.

# **Monitoring & Evaluation**

National Associations will apply a number of monitoring techniques to measure and report on the progress of this strategy which will capture both quantitative and qualitative data.

National Associations will put in place systems to monitor and report the following data on an annual basis. Information will be provided to UKAD on request.

- Collate data on attendees of the workshops (sharing this information with UKAD as required)
- Collate feedback from attendees at any formal education session delivered.
- Collate feedback Educators on the formal sessions they deliver.
- Web-hits to its anti-doping links on its web-page.
- Number of canoe/kayak individuals undertaking Coach Clean and Clean Sport Advisor annually (information to be obtained from UKAD) – UK only.
- Number of canoe/kayak Global DRO enquiries (information to be obtained from UKAD) UK only.
