Tuesday 12th April 2022

The International Panel would like to start this statement by thanking the volunteers, officials, Regatta Committee and SRC for creating and delivering a successful April regatta.

Selection Statement

Within its deliberations the IP were understanding of the lack of competition opportunities for athletes during the Covid pandemic. All members of the panel were in agreement that this selection represented an opportunity to allow available athletes and crews to gain valuable experience internationally. As a result, when applying performance standards during this selection the IP took the view that inclusion was of paramount importance within the framework of the various selection policies.

This determination should be viewed in isolation and is specific to the circumstances of this selection. At forthcoming selections for World and European Championships, the IP will continue to apply the performance standards detailed within each policy based on the individual circumstances at that time.

In line with the published Canoe Sprint Performance Strategy published in March, the IP would also like to encourage all athletes and coaches to consider the opportunities presented within crew boats at the June/July selection regattas and Junior Canoe boats in July.
