

British Canoeing - Canoe Sprint & Paracanoe International Panel Statement - Thursday 16th June 2022

Following the June regatta and publication of the Paracanoe team on 7th June and the Sprint team on 10th June, the purpose of this statement is to follow up with final details from both statements that remained outstanding:

VL2 Men - Paracanoe World & European Championship team:

As a result of suspending the selection of Va'a events due to the weather conditions, there was one final three race opportunity on Thursday 16th June for the two eligible athletes who had yet to demonstrate the published performance standard to be selected. The athlete listed below have now made the published performance standard and are therefore confirmed to the 2022 Paracanoe World & European Championship Teams:
