

Canoe Sprint Senior Selection Policy 2023

Introduction

The focus of the 2023 senior policy is to qualify places for the Paris Olympic Games as well as to provide development opportunities for those on pathways to that level. The domestic regattas which are at the most appropriate times of the year have been chosen for international regatta selection. A World Cup Pool of athletes will be selected in April, being mindful that World Cup 1 will have a dual role as it is also selection for the European Games. For those focused on peaking at the World Championships and qualifying Olympic quota places, the July regatta becomes a single selection point and also selects the World Cup 3 Team. Athletes will need to have clarity on their objectives particularly around the European Games, as there is only one week separating this event from the July regatta. This year a new 'best of three' type racing format is being introduced at the July regatta for single and double boat Olympic events. This is intended to ensure the consistently best athlete is identified in a format that also reflects an international racing schedule. Please note that we have tightened the policy for exceptional circumstances. Athletes need to make sure that they do everything they can to keep injury and illness free and race at the relevant selection events.

SECTION A: PURPOSE AND PRINCIPLES

1. Purpose

The purpose of the Canoe Sprint selection policy is to clearly outline the processes which will lead to the selection of the GBR Senior Canoe Sprint Teams for all 2023 international events named within this policy. It also aims to support the longer-term goals of the sprint strategy to 2024 and 2028.

2. Principles

- 2.1. The primary focus of National Team Selection will be to optimise performance in targeted Olympic events, in particular seeking to maximise qualification of 2024 Paris Olympic Games quota places.
- 2.2. The Selection Policy seeks to select the best athletes in a transparent way that prioritises optimal preparation time for achievement of international success.
- 2.3. Selection will be based on results in selection races and subject to an assessment of performance standards. All eligible athletes will be considered equally for selection against the stated selection criteria regardless of club, training location, age, Home Nation and programme status.
- 2.4. The Selection Policy provides opportunities to use unfilled event places for development opportunities.
- 2.5. Selections will be made in alignment to, and in support of, targeted events and boat priorities of the WCP in 2023.

SECTION B. ELIGIBILITY AND PERFORMANCE STANDARDS

3. Eligibility

- 3.1. To be eligible to be selected to any 2023 GBR Team, athletes/crews must meet the following conditions (full detail can be found in British Canoeing's [Eligibility Policy](#)):
 - 3.1.1. Meet age and nationality criteria for international competitions as outlined below
 - 3.1.2. Be a full member of British Canoeing or Home Nation Association that enables participation in competition
 - 3.1.3. Athletes on a funded programme need to have signed their Programme Athlete Agreement. Athletes outside Programme funding will also be expected to sign up to the British Canoeing Great Britain Team participation agreement on accepting selection at least two weeks before travelling to the first competition and settle any outstanding payments prior to travel.
- 3.2. Where athletes compete in more than one eligible selection event, the policy will be applied in isolation for each specific event.
- 3.3. British Canoeing reserves the right to deselect an athlete who has been found guilty of a disciplinary offence under British Canoeing/ICF rules. This includes doping offences.

4. International Eligibility

- 4.1. Selection will be subject to eligibility in accordance with competition rules laid down by the International Canoe Federation (ICF) and the European Canoe Association (ECA).
- 4.2. The first year an athlete can compete at World and European Senior/U23/Junior Championships is the year of their 15th birthday

5. Performance Standards

The International Panel (IP), will apply a performance standard for all selections under this policy to ensure athletes/crews are of the appropriate level for the competition they are being considered for. The detail of the application of performance standards can be found in **Appendix 1**. The IP reserve the right to not apply a performance standard either at all or as prescribed in **Appendix 1**, where circumstances arise which in the IP's reasonable opinion would make the application of the performance standard at **Appendix 1** unsuitable.

SECTION C: GREAT BRITAIN SPRINT SENIOR TEAM SELECTION 2023

6. Senior Team Selection Overview

- 6.1. Athletes may choose to prepare for early season international competitions by competing in the April regatta (15th/16th April) for a place in the World Cup 1 & 2 Pool and European Games selection or alternatively may focus just on selection for the World Championships and World Cup 3 selection Regatta on 1st/2nd July at Holme Pierrepont.
- 6.2. The stand-alone selection point for the World Championships and World Cup 3 allows athletes to prepare for this without the constraints of a multi-point selection.
- 6.3. Selection for all events will be based on either pre-selection or performances in the identified selection regattas.

7. 2023 Senior Sprint International Competitions and Selection Announcements

Announcements by the IP of selections made at identified selection regattas will be as per Table 1:

8.2. Events outside of World Cup 1&2 Pool

The highest ranked boat in the events listed in Table 3 will automatically be selected to their respective event, subject to meeting the performance standard.

9. Pre-Selection

9.1. Athletes who achieved an A Final performance in Paris Olympic events at the 2022 Senior World Championships are pre-selected into the 2023 World Cup Pool (see Table 4 below).

9.2. **Where an athlete has achieved multiple A Final performances, the biggest boat type will be used as the pre-selected boat in the formation of the pool.**

9.3. Athletes who achieved a medal winning performance in a non-Olympic event at the 2022 Senior World Championships will be pre-selected in that event for the 2023 World Cups (see Table 5 below).

9.4. All Pre-selected athletes must confirm their intention of taking up this place by 31st March 2023 with the IP via email.

10. World Cup 1&2 Pool Qualification Criteria

10.1. Subject to the assessment of performance standards, athletes will be selected to the 2023 World Cup pool by achieving a race position at the selection regatta on April 15th/16th in line with the tables below.

10.2. Athletes will be selected in either a specific event **and** to the World Cup Pool **or** to a World Cup Pool only place.

10.3. In the event of places in a designated 'pool' remaining unfilled either by the same athlete achieving the criteria in more than one event or another reason, the IP will consider the allocation of additional places in the following way:

10.3.1. All athletes in the events identified in the policy who have achieved the specified performance criteria will be considered.

10.3.2. The athletes above will be ranked in order of their percentage from the race winner in their event with the smallest percentage ranked first.

10.3.3. The IP will consider the ranking and available places to determine any additions in order of the closest percentage to the winner of the event.

11. World Cup Entries Determinations

- 11.1. Pre-Selected boats as per section 9, and the winning boat in each event listed in Table 6, 7 and 8 will be offered an entry in that specific event at either World Cup 1 or World Cup 2. All other athletes are entered to the World Cup Pool.
- 11.2. Where there are available entries after the initial allocation of places, the relevant British Canoeing section coach will consult with athletes and their personal coaches to determine how any available entries are filled for the events outlined in section 10 - World Cup Pool events. The recommendations on event entries will be made by the British Canoeing Senior Podium Coach and ratified by the IP. Possible rationale will include, in no priority order and not limited to:
- 11.2.1. Race ranking from the April selection regatta in specific events
 - 11.2.2. Trialling of crew combinations
 - 11.2.3. Development opportunity for athlete(s) to have more start lines

EUROPEAN GAMES SELECTION

12. Qualification Criteria

- 12.1. **Where athletes have been pre-selected subject to section 9 or are the highest ranked boat from the April regatta in events in Table 9 they will be selected to race in the selection race at WC1.**
- 12.2. Where athletes have been nominated for multiple events within a European Games team, they and/or their coach will be consulted **prior** to the relevant IP meeting regarding the events they would like to be considered for, and a prioritisation of these events. An athlete or boat will be guaranteed nomination in their first priority boat only. If an athlete wishes to be considered for multiple events the IP will at its sole discretion make a decision on which event(s) the athlete is nominated for.

12.3. Subject to point 12.1, 12.2 and an assessment of the performance standard, the highest ranked available boat in the events in Table 9 at World Cup 1 will be nominated to the BOA for selection to the European Games team.

Clarification to 12.3:
Where athletes/boats do not make finals and the highest ranked boat is decided in either the semi-final or heat, the highest ranked boat will be defined as the one that had the highest finishing position within that round of racing.
The nomination of the second British boat as a reserve will be at the total discretion of the IP.
Any additional race entries, including for Mixed K2 and C2 200m can be made from athletes already selected to the team, and where the event does not compromise their priority races in accordance with section 14.4.

WORLD CHAMPIONSHIPS SELECTION

13. Qualification Criteria

- 13.1. Events highlighted (in bold*) within Table 10 will be subject to a best of three race format. Any athlete or boat winning race 1 and 2 will be deemed the highest ranked boat. In the case of a different winner in race 1 and race 2, there will be a third race between the two first placed boats from races one and two to confirm the highest ranked boat in that event.
- 13.2. Where athletes have been selected for multiple events within the World Championships, they and/or their coach will be consulted **prior** to the relevant IP meeting regarding the events they would like to be considered for, and a prioritisation of these events. An athlete or boat will be guaranteed selection in their first priority boat only. If an athlete wishes to be considered for multiple events the IP will at its sole discretion make a decision on which event(s) the athlete is selected for.
- 13.3. Subject to point 13.1, 13.2 and an assessment of the performance standard, the highest ranked available boat in the events in Table 10 at the July 1st/2nd 2023 selection regatta will be selected to the World Championships team.

- Race entries for the Men's K4 1000m, Women's K2 1000m, Men's C4 500m, Men's C2 1000m, Men's K2 200m and Women's C4 500m can be made from athletes already selected to the team, and where the event does not compromise their priority races.
- Up to two athletes finishing within 102% of a winning selected athlete will be named as a reserve.
- Events highlighted (in bold*) above will be subject to a best of up to three race format.

WORLD CUP 3 SELECTION

14. Qualification Criteria:

- 14.1. Athletes selected to the 2023 World Championship team in Olympic events only will also be selected to compete at the ICF World Cup 3 in Paris, FRA.

SECTION D: GENERAL PROVISIONS, CONTINGENCY AND EXCEPTIONAL CIRCUMSTANCES

15. General Provisions

- 15.1. The IP reserves the right not to nominate, or to de-select for the World Championships or any international event, any athlete or reserve on the following grounds:
- 15.1.1. Medical grounds – i.e. when an injury/illness may, in the reasonable opinion of the IP, inhibit the achievement of appropriate performance and/ or mean the athlete cannot reasonably be considered fit to travel; or
 - 15.1.2. Suitability as a team member, where for example (but not limited to) an athlete's behaviour or attitude leads the IP to determine in its opinion that the selection of such athlete would be inappropriate; or
 - 15.1.3. Poor form – i.e. when an athlete's form in events and/or training has decreased to such a level that, in the opinion of the IP, they would no longer be able to achieve the required level of performance to be competitive at the applicable competition(s).
- 15.2. Any decisions taken in accordance with 15.1 will only be made following consultation with the athlete, appropriate BC coaches and/or medical reports and in the case of 15.1.3. include reference to applicable performance standards.
- 15.3. Following the selection of a crew boat to the European Games or World Championships, the British Canoeing Senior Podium Coach must propose any changes to the composition of the crew due to injury, illness, poor performance or other circumstance to the IP who will consider the circumstances and determine an appropriate process to follow.
- 15.4. The British Canoeing Senior Podium Coach has discretion to use events within the World Championships, or any international event within this policy, that are unfilled for further start line opportunities that do not otherwise compromise performance. This must be communicated to the Chair of the IP in advance of the nominal entry deadline for the event.
- 15.5. A non-travelling reserve may be named in each individual event based solely on position in the identified selection race where performance standards have been achieved. In order of selection, named reserves will only travel in the event of injury or illness to a selected athlete or where a place(s) is declined.

16. Contingency

- 16.1. The IP retains the right to implement contingency measures where circumstances arise that prevent full, fair and competitive racing and adapt racing to ensure as fair a selection process as possible. This may include circumstances such as weather conditions and covid-19 implications.
- 16.2. The IP will monitor weather conditions ahead of a selection race, during the race and has a process for communication of real-time information.
- 16.3. If weather conditions or other significant issues arise making it inappropriate or impossible to conduct a selection race during or, in advance of competition, the IP may declare that a race(s) will not be used for selection and invoke one or more of the following non-exclusive alternatives:
- 16.3.1. Rescheduling of any affected selection race(s) to early morning/ evening racing within the same regatta (if scheduling and weather conditions permit).
 - 16.3.2. Rescheduling of any affected selection races to an alternative competition (if appropriate)
 - 16.3.3. Rescheduling to a reserve date if available and appropriate.
 - 16.3.4. Amending lane draw for direct comparability of performances
- 16.4. Any decision made under these provisions of the policy will be made by a minimum of two IP Members and where possible, in consultation with the chief official.
- 16.5. All IP announcements relevant to contingencies will be posted on www.britishcanoeing.org.uk. During competitions, important information will be posted at race control on the live results messaging, on the British Canoeing social media or messaging App.

17. Exceptional circumstances

- 17.1. Should an athlete miss a Selection event due to illness or injury during, or prior to, elements of the 2023 selection process; or have any other exceptional circumstances, the IP reserves the right to provide an opportunity for such a boat to be eligible for selection. For the purposes of this clause, exceptional circumstances are unplanned, unexpected, unavoidable and unforeseen.

- 17.2. Where an athlete wishes to invoke this clause, exceptional circumstances requests should be directed to the IP prior to the commencement of the selection competition via email at enquiries.internationalpanel@britishcanoeing.org.uk and should provide:
- 17.2.1. Certificated evidence of illness or injury, or other significant exceptional circumstance.
 - 17.2.2. Any evidence the athlete wishes the IP to consider which demonstrates in both training and racing, a superior performance level than other selected athletes.
- 17.3. To be considered for an exceptional circumstances, an athlete must be able to demonstrate the following performance level:
- 17.3.1. For Senior Teams selection, the athlete should have made a final in that event at the Olympic Games, Senior World and/or Senior European Championship in the previous 24 months or can demonstrate the equivalent in the case of a crew boat in the previous 24 months.
- 17.4. When considering whether an athlete meets the criteria outlined above, the IP will consider the following:
- 17.4.1. The athlete's training and racing profile (from GBR performance analysis data);
 - 17.4.2. ICF World Ranking, Performance at Olympic, Senior World Championship, Senior European Championship and/or World Cup races within the previous 24 months.
- 17.5. Where the IP accepts an exceptional circumstance request following the process detailed above, the IP reserves the right to:
- 17.5.1. Identify a single race opportunity whereby the lowest ranked boat that has been selected and the identified athlete(s) would compete for a GBR Team place. If this situation arises more detail would be provided following the IP meeting immediately after the appropriate Selection race series.
 - 17.5.2. Where no athlete has been selected for the relevant event under this policy, accept the exceptional circumstances and select the athlete;
 - 17.5.3. Substitute the selection of the athlete under this policy with the selection of the athlete making the exceptional circumstances request
- 17.6. All decisions under this Clause that relate to injury, illness (including Covid-19) or medical conditions will be determined by the IP members. When assessing if an athlete is fit to race, the decision of the IP is final.
- 17.7. **The IP has the sole discretion to invoke the provisions in this clause and any decision is final and not subject to appeal.**

SECTION E: GENERAL INFORMATION

18. Responsibility

The Canoe Sprint IP (IP), which is appointed by and reports to the Board of British Canoeing, is responsible for all aspects of developing, approving and managing the implementation of the Canoe Sprint selection policies. The Terms of Reference can be found [here](#).

19. Conflicts of Interest

Any member of the IP shall declare any conflicts or potential conflicts of interest and shall refrain from participation in the discussion of and any vote in respect of any selection matter in which they have a material conflict of interest. If a person has any queries in this area, they should consult the British Canoeing Director of Governance.

20. Policy Changes

- 20.1. The selection policy may be amended at any time by British Canoeing for one or more of the following circumstances:
- 20.1.1. Any changes in rules governing a particular event;
 - 20.1.2. Any change in ICF eligibility, rules or programme of events;
 - 20.1.3. To give effect to the selection process in case of a drafting error or oversight
 - 20.1.4. To clarify any ambiguity to the intended meaning of the selection policy
 - 20.1.5. Any other reason determined by British Canoeing at its total discretion that is in the best interest of British Canoeing and in line with the principles outlined for selection
 - 20.1.6. Circumstances arising from Covid-19
- 20.2. Any changes will be communicated on www.britishcanoeing.org.uk

21. Appeals Procedure

- 21.1. Certain decisions made throughout this Policy are not subject to appeal and where this is the case, specific reference will be made to the decision being final. For other selection decisions made under this Policy, the British Canoeing Appeals process applies and this procedure can be found [here](#).
- 21.2. Guidance is available from the British Canoeing Performance Wellbeing Coach, zofia.campbell@britishcanoeing.org.uk. UK Sport funded World Class Programme athletes who require support and advice can also contact the BEAA at support@britishathletes.org.

22. Data Protection

- 22.1. British Canoeing is a privacy conscious organisation and is strongly committed to an individual's right to privacy. All data gathered during the selection process will only be utilised for the purposes of an athlete's participation in a GBR Canoe Sprint Team. This may include administering their event/race entry and certain information may be published as part of the results and rankings of the event/race.
- 22.2. Any personal data will be processed and stored in compliance with the British Canoeing Data Protection Policy and in accordance with all applicable Data Protection laws in effect at the time of publication of this Selection Policy, including but not limited to, the Data Protection Act 2018 and UK GDPR.
- 22.3. Further information on British Canoeing's approach to privacy and data protection, including British Canoeing's privacy notices, policies and contact details, can be located in their Privacy Centre (<https://www.britishcanoeing.org.uk/about/privacy-centre>). Should an athlete wish any data British Canoeing hold relating to them to be deleted at any point; they should contact British Canoeing at GDPR@britishcanoeing.org.uk.

23. Policies

This Selection Policy operates in conjunction with all relevant British Canoeing policies including but not limited to, Equality, Anti-Doping Policy, Pregnancy, Safeguarding, Anti-Bullying Policy, Covid Vaccination Policy and Anti-Bribery Policy.

24. Communications

British Canoeing is committed to providing open and informative communication in relation to selection. All athletes will receive formal confirmation of the selection and for those athletes who wish to discuss the outcome of decision made by the IP, the Chair of the IP will be available to speak informally to athletes and in the case of minors, parents.

25. Force Majeure

"Force Majeure" means any act, event, omission, cause or circumstance not within the reasonable control of British Canoeing or the race organisers, including but not limited to any strike, lockout or other industrial action, any civil commotion or disorder, riot, invasion, war or terrorist activity or threat of war or terrorist activity, any action taken by a governmental or public authority of any kind (including, without limitation, not granting a consent, exemption, approval or clearance), any fire, explosion, storm, flood, earthquake, subsidence, epidemic or other natural physical disaster. In the event of such Force Majeure affecting the application of the policy, the IP shall have the sole discretion, in consultation with the British Canoeing Director of Governance, to make a decision in line with the principles, strategy and mission of this selection policy.

26. Paris 2024 Olympic Selection

The IP will publish the 2024 Olympic Selection Policy by 31st December 2023. In the event that the 2024 Olympic selection process will include performances in the 2023 senior world championships, details of such a process will be published by the end of June 2023 prior to selection for the 2023 World Championship Team.

Appendix 1 – Performance Standard Data 2023 – International Panel Selection Guidance.

As per section 5, Performance Standards will be applied to all performances considered under the selection policy. This is to ensure a level of consistency to selections across classes and that all athletes are selected for the appropriate level of competition.

The process for how performance standards will be applied:

1. The IP agrees the standard of team as expressed as a minimum performance level. E.g., Ability to achieve a B final or better.
2. The IP collects all times from the relevant selection regatta and collates the % difference to World Leading Time for each event.
3. The IP collects weather information from the relevant selection regatta through the event.
4. The IP then uses available information to agree where the % of WLT will be set for that selection event, taking into account the above points.
5. The IP may adjust the standard applied to selections to reflect changing conditions during the regatta and the performance impact of conditions on different events.
6. The IP may adjust the standard applied for a particular event to reflect the most recent knowledge of performances within that event.

Whilst this process relies on objective data it is acknowledged that these decisions are ultimately subjective in nature.

The objective data used as guidance in decision making for the IP is shown in Table A and Table B below.

Table A shows the Senior, U23 and Junior WLTs and the % difference between the Senior WLT and U23 and Junior WLTs. A comparison of the % differences can be used as part of the process to understand the performance standards.

Table B shows reference selection ranges for senior, U23 and juniors that will be used as a starting point to agree the performance standard of the relevant team being selected. HPP course record times are also shown as an additional reference for the determination of appropriate performance standards.
