#### **Paracanoe World Championships Team selection**

The Paracanoe World Championship selection is a designated senior team event. Up to 2 athletes can be selected per sport class in Paralympic events. This is the last opportunity for Paracanoe athletes to gain eligibility to compete at the Paralympic Games in Paris and is also the last opportunity to gain quota places in specific events. Subject to appeal, the following athletes are selected:

## 2024 Paracanoe European Championships pool selection

New athletes were required to achieve the development performance standard and existing athletes were required to achieve the senior performance standard.

#### Canoe Sprint European Olympic Qualifier, World Cup 1 & 2 and European Championships

The European Olympic Qualifier is the last opportunity to gain quota spots for the Paris Olympic Games, therefore there is a high performance standard to ensure athletes selected have a genuine chance to qualify, knowing that the standard of competition will be extremely high.

World Cup 1 is immediately after the Olympic Qualifier and a slightly wider team will be selected based on being A & B final capable.

World Cup 2 is a development opportunity for the senior team, with some U23 athletes included to support race preparation in target events of the U23 World and European Championships.

The Senior European Championships will be a wider team, but athletes selected will have A & B final capability, with it being an Olympic year, it will be a good racing opportunity for athletes who have a focus on LA 2028.

#### Explanation of how the performance standard was applied

The weather was extremely challenging over the weekend with strong head winds across both days, including gusty weather on Saturday afternoon. Due to Monday's forecasted weather conditions predicted to be worse, contingency plans were actioned and the races planned for Monday were moved into Sunday, once it was clear that a number of race 3's were not needed. The only exception being the Women's C2 500m where only 1 boat entered, Up to 2 races were initially planned for, but due to the weather and a busy schedule they had one opportunity to race, this is still in line with the policy which states the Olympic events would have 'up to 3 races'. With weather considered including increased impact in certain disciplines and how the weather developed over the days, the following performance standards were applied:

- The European Olympic Qualifier and World Cup 1 Saturday 125% WLT and Sunday 117% WLT
- World Cup 2 and European Championships Saturday 130% WLT and Sunday 126% WLT

#### Reserves

As per 9.5 in the policy, for the Poznan World Cup the IP can select up to 2 entries in Olympic events and 1 entry for Non - Olympic, therefore reserves who hit the performance standard have been listed at the discretion of the IP.

#### Pool for K4 crew boat formation

Women's crew boat formation will take place at a later date, after the European Olympic Qualifier. All of the athletes below will be invited to crew boat training opportunities and a formation opportunity will be developed when it is appropriate.

In relation to this, it is also noted that the World Class Programme position is that where U23's have qualified for senior and U23 crew boat opportunities, they should prioritise U23 crew boat formations.
