

# Paddle UK - Canoe Sprint & Paracanoe International Panel Statement Wednesday 12th June 2024

The International Panel would like to start by thanking the volunteers, officials, Regatta Committee and SRC for creating and delivering another successful National regatta.

# Junior and U23 World Championships Championships selection

The Junior and U23 World Championships is a key delivery event for Junior and U23 athletes. Selection is on a 'first past the post' basis with up to 2 reserves nominated if within 102%.

### **Performance standards**

At the beginning of the selection meeting the International Panel considered the application of appropriate performance standards using the steps detailed in Appendix 1 of the selection policy. The ranges of performance standard %WLTs were increased significantly (compared to those indicated in Table B) due to the strong head and cross winds experienced over the weekend. Average wind speeds and peak gust speeds were recorded for each event. Wind directions were noted and varied over the distances. In general terms the IP observed and considered that:

- There was a short window on Saturday morning which saw the most favorable conditions of the weekend. (U18 C2 500, U18 K2 500 and U23 K2 500 finals took place)
- Sunday's conditions were generally slower than Saturdays.
- 1000m events were more affected by the conditions.
- Canoe paddlers and Junior Female paddlers were more affected by the conditions.
