International Panel – Selection Announcement – 25th October 2023

Stage 2 and 3 of the Nomination process will take place in April & June 2024 respectively as published in the policy

ALL athletes, coaches and members of the community are reminded that the purpose of publishing the Stage 1 Paris 2024 nominations is to initiate the British Canoeing appeals process. All nominations are subject to appeal and not confirmed until the conclusion of the British Canoeing appeals process and the final nominations being accepted by the BOA. No confirmation will take place until an official announcement of any nominations by Team GB on 15th November. Therefore:

- All Athletes need to refrain from posting on social media discussing being selected or nominated for the Olympic Games until the official announcement made by the BOA (15 November)
- Any interviews done prior to the BOA announcement are unable to mention Olympic selection as it is not confirmed.
- It is requested that fellow athletes and members of family and the community refrain to talk about it or post about it publicly until after the official announcement on 15th November.

IMPORTANT – Athletes will be contacted by the canoe slalom team manager before the 31st of October with more information about the 2024 international race season. Athletes are asked to confirm their intentions to take up their place in the 2024 SNR Canoe Slalom team by the 20th of January 2024 either via email (fieke.blackwell@britishcanoeing.org.uk) or in person to the team manager.
