Role of the International Panel

Paddle UK's International Panel has been established to ensure robust and transparent selection of athletes to GBR teams. The International Panel's role is to:

- Support the agreed Paddle UK performance strategy and strategic medal objectives;
- Influence, scrutinise and approve selection policies for all GBR Teams in Canoe Sprint and Paracanoe;
- Select GBR international teams in Canoe Sprint and Paracanoe in accordance with the relevant selection policies; and
- Ensure effective communication around selection policy development and decisions.

Key Responsibilities

The International Panel's key responsibilities are to:

- Annually approve and recommend to the Paddle UK Board clear selection policies for all Paracanoe and Senior, Under 23 and Junior Sprint Canoe Great Britain representative teams.
- Support the development of selection policies annually, ensuring they:
 - o are aligned to performance strategy;
 - o are clear, transparent and embed excellent governance;
 - take into account learnings from past policies, decisions and appeal outcomes;
 - o are subject to open consultation and take into account all feedback provided;
 - embed all relevant Paddle UK policies and procedures, particularly in relation to conduct; and



- o are published in a timely manner;
- Apply approved selection policies to select athletes, ensuring robust consideration of all relevant performance and performance related information and clear and transparent communication of decisions.
- Provide feedback to the Paddle UK Board where required to determine how best Paddle UK should effectively and proactively respond to policies and strategies from the IOC/IPC, ICF and ECA.

Person Specification

We are looking for candidates with skills in the following areas:

- Knowledge of, or experience of, Sprint and/or Paracanoe sport;
- Whilst not essential, it would be helpful for candidate to have had experience in the development and implementation of selection policies in sport;
- An understanding of the role and responsibilities of a National Governing Body;
- An understanding of the barriers that under-represented groups may face in relation to selection:
- Excellent attention to detail;
- An ability to analyse performance data;
- An ability to provide constructive feedback, both to the organisation and to others within the group;
- Creative with solutions and suggestions;

Personal Qualities:

- Highly developed sense of personal integrity, fairness and independence;
- Able to respond positively to challenge;
- Flexible, adaptable and able to meet changing priorities associated with the role.
