## International Panel Statement

### International Panel – Selection Announcement – 3<sup>rd</sup> April 2024

Firstly, huge thanks are due to the amazing volunteers who made the race happen in such a professional way and in particular thanks to Dave Spencer who organised the race and who compiled the selection points tables once again. It was great to be able to deliver a full format kayak cross race to enable athletes to experience head-to-head racing so thank you for everyone's help in making this happen as it was not without its challenges.

#### 1. 2024 Great Britain Kayak Cross Teams:

## 2. Paris 2024 – Olympic Team Nomination – Stage 2

In line with the published 2024 Olympic selection policy, the International Panel considered the process outlined for stage 2 of the policy. It was agreed that no further nominations will be made to the British Olympic Association at this stage 2 of the selection process.

The meeting finalised the date of the international panel meeting to determine any nominations as part of the final stage of the policy (stage 3) which will be held at 3pm on Wednesday 12<sup>th</sup> June 2024. Please be aware that due to the proximity to the Olympic Games a fast track 24 'intention to appeal' timeline has been applied from the Paddle UK Director of Governance. The International Panel anticipates publishing the outcome of the stage 3 selection process on Thursday 13<sup>th</sup> June.

### **IMPORTANT – Acceptance of places**

For the GBR Senior Kayak Cross team 2024: Athletes will be contacted by the team manager with the 2024 logistics briefing. Athletes are asked to confirm their intentions to take up their place in the 2024 SNR Canoe Slalom team by the **8th of April 2024** by completing a form shared in the logistics briefing.

For the GBR U23 and Junior Kayak Cross team 2024: Athletes will be contacted by the team manager with the 2024 logistics briefing. Athletes are asked to confirm their intentions to take up their place in the 2024 U23 and Junior Kayak Cross team **AFTER** the HPP selection race and by the **22nd of April 2024** (*after the GBR U23 and Junior Canoe Slalom team 2024 announcement*) by completing a form shared in the logistics briefing.

### **Announcement of selection dates and venue(s) for 2025:**

The International Panel has discussed provisional dates and venues for the 2025 selection series. The International Panel has identified two provisional weekends of the 29/30 March and 12/13 April 2025 at Lee Valley and Nottingham and will now work with the slalom committee, venues and identify potential race organisers before final confirmation.

In reaching the proposals for 2025 dates and venues, the IP has considered many factors including the additional costs for volunteers and competitors and the clash with Easter, that Scottish school exams start around the 22<sup>nd</sup> April and a desire to combine Junior, U23 & Senior selection with at least one premier race at each weekend depending upon the final agreed format. Full detail of the format and policy detail will be determined following a review of the 2024 process after the HPP race and a consultation on next year's policy late in 2024.
