Friday 19th April 2024

The International Panel would like to start by sincerely thanking the volunteers, officials, Regatta Committee and SRC for creating and delivering another successful National regatta.

Junior and U23 European Championships selection

The Junior and U23 European Championships is a key event for the development of junior and U23 athletes. For juniors the highest ranked boat for each event was selected, subject to performance standard. For the U23's, kayak athletes were selected to a pool. Selection for this was based on winning a K1 or K2 event, or being within 104% of the winner. Remaining boats were nominated to the pool using discretion as laid out in the policy. In particular, for the women's pool all athletes were selected to allow a viable K4 and in the men's the performance standard against WLT was considered. Highest ranked boats in all events, including Canoe, are offered first refusal.

Performance standards

The weather conditions over the weekend made racing extremely challenging which was taken into consideration when applying a performance standard. As the Junior and U23 European Championships has been identified as a key development opportunity, the panel were lenient in the application of the performance standards. This is to ensure appropriate development opportunities were provided to as many paddlers as possible. The IP would like to make clear that a more stringent performance standard will be applied when selecting the Junior and U23 World Championships team.
